

# Brother Recon Fallen Warrior Memorial

Brother Recon has been engaged in creating a Fallen Warrior Memorial for the last 6 years and we are now in the final stage and able to complete this endeavor. We are now raising funds for the final casting that will be unveiled at the 2020 Annual Recon Challenge at Camp Pendleton CA.

After the death of SSgt Caleb Medley in a parachuting accident in Perris California in 2013, I found myself struggling to deal with the loss of one of my Marines at home. The issue unlike overseas, is the fact that it happened in our own back yard here at home and I could not leave this event behind like I had done for years overseas. My coping mechanism for this event became the creation of Brother Recon.

Over the last 6 years we have supported the

Reconnaissance community, placed a memorial at Sky Dive Perris of SSgt Medley and continually supported the Annual Recon Challenge with funds raised from the sale of our products but our biggest initiative grew to become the Fallen Warrior Memorial that will be placed at the Reconnaissance Training Center at Camp Pendleton Ca.

This initiative has become a part of my life and I promised Caleb's mother that I would complete this memorial no matter what. Brother Recon has no staff, partners, or employees it's just me and my wife Kathy. We have spent the last 6 years building our product line and investing everything we make back into the business or the Reconnaissance Community and we are finally at the point to bring this memorial to life, but we need everyone's help. The sculpture is currently in the molding and digitization process and will be ready for the final production soon. We are asking that everyone help share this message with friends, family, and Contacts and donate if you can.

The memorial is a 7-foot bronze sculpture casted after SSgt Caleb Medley with the help of Mark Rawson, one of Caleb's best friends.



This Memorial will represent all our fallen Reconnaissance Marines and SARC Corpsman that have given their lives for this great nation and the Reconnaissance Community.

So far this year we have raised \$26,400 of the \$45,000 required to finish the project.

We have sent John Phelps the artist that has been working with us since the beginning \$46,205 to date. We have another \$3,195 in the fund giving us a total of \$49,400.

## 2019 Membership Criteria

## **Annual Dues - \$40**

#### **Regular Members:**

Regular Members include all officers and enlisted members of the Armed Forces of the United States of America or her Allies who are now serving, or who have served, with any Force Reconnaissance Company, Regular or Reserve, Marine Division Reconnaissance Battalions, Regular or Reserve, Amphibious Reconnaissance units between 1943 and 1958, Test Unit One, and Special Mission Units. Only Regular Members shall have voting rights and serve as officers or on the Board of Directors of the Corporation.

#### **Associate Members:**

Associate Members include civilians and veterans of the U.S. Armed Forces and Allies who do not meet the "Regular Member" requirements as stipulated above, but who did make a significant contribution to the development of, or advancement to, operational procedures or techniques inherent in Force Reconnaissance operations or who made a valuable and unique contribution to either operational Force Reconnaissance units or to the Corporation. Associate Members do not have voting rights and may not serve as officers or on the Board of Directors of the Corporation.
